SUBJECT: Reports from the Management Team for December 2022 and January 2023

This report is provided to give you a brief synopsis of the programs provided, and services rendered through the dedication and commitment of Santa Cruz County Animal Shelter's (SCCAS) staff and volunteers. Shelter statistics for this period are attached.

General:

So much has gone on since we last met for a regular Board Meeting! There were: floods; evacuations of animals; our surgery center is now set up and ready to go; and we hired a new General Manager! A big thank you to all of the Board members that have supported us through these very challenging times and for hiring a great new General Manager. We have also had tremendous support from the reimagined Satna Cruz County Animal Shelter Foundation and we can never thank them enough.

I think the greatest recognition and praise should be for the <u>employees and volunteers at the Shelter</u>. They have been through so much change and transition while being under tremendous pressure and yet doing so much more with fewer staff and resources. They have endured all of this along with the recent disaster and done it with a smile on their faces and a spring in their step, a truly inspiring group of humans passionately caring for animals that need as much care and attention as we can give them.

We had great success during the evacuations from the January flood events by keeping people and their animals together. This was a collaborative effort with the County of Santa Cruz as well as the cities of Watsonville and Santa Cruz. We reduced the stress on the people being evacuated, the stress for their animals and the resources needed to care for everyone. I also wanted to send a big thank you out to Equine Evac for all of their amazing help during the disaster response and subsequent follow up.

Given our staffing vacancies and workload we are judiciously managing our resources as we carefully plan for a select number of events in 2023. Fortunately, our non-profit partner, the Santa Cruz County Animal Shelter Foundation has stepped up and continues to provide opportunities for events that highlight our adoptable animals and at the same time generate some revenue. They recently provided us with a check for \$8000 to support volunteers and helping to fully bring back the St. Pittie's day event. We are also working on several smaller events that are not as time intensive but help to get the word out about our adoptable.

Lastly, as we continue to look at a potential upcoming budget shortfall, we have begun to evaluate how operations can be streamlined to cut costs and create better efficiencies. To that end we have decided to close the forward-facing operations of the main Shelter on Tuesdays and Wednesdays, this will be for the foreseeable future. This will better allow staff to concentrate resources and energy on animals in our care, the surgery center and delivering more efficient service to our community. We are continuing to evaluate the most effective way to make this happen but the closure of the lobby will be starting Wednesday March 1st and will then be Tuesdays and Wednesdays through the rest of 2023.

The last couple of months have been a bit of a whirlwind and I am honored that I was allowed to help support the Shelter and our community in such an impactful way. Thank you for the opportunity to serve and support such an amazing group of volunteers and employees!

Administrative Services Board Report December 2022 and January 2023 Joe Phares, Admin. Svcs. Officer II

Personnel

New Hires

- Tina Crivello Extra Help Animal Care Worker. Tina is a longtime Shelter volunteer who was recently hired in an extra help capacity to assist with both animal care and client services. Tina's start date was 02/08/23.
- Annie Miller Extra Help Animal Care Worker. Annie has a deep background in animal care and will also cross-train in both animal care and client services to add flexibility to our workforce. Annie's start date is 02/12/23.

Under Recruitment

- Registered Veterinary Technician – this position has been vacant this Fall 2021. Elsewhere on this agenda the Shelter is requesting authorization to establish a hiring and retention bonus to entice potential candidates to apply and to help retain existing RVT staff.

Facilities

- Surgery Suite All new equipment has been installed. An anesthesia waste gas
 evacuation system was installed by George Wilson Inc. and JM Electric. New
 anesthesia equipment was tested and calibrated. Next up: staff are selecting some
 cabinetry to add storage in the suite. Staff are preparing to begin spay/neuter
 surgeries in the new space in the coming weeks.
- Security Camera System Bandit Systems was onsite on 01/31/23 to discuss expansion of the camera system to provide more complete coverage of the building exterior. It is anticipated that two additional cameras will be installed.
- The deteriorating catio located on the patio off the break room was removed and the space has been cleaned up and made available for outdoor staff space.

Information Services

 New iPhone for Client Services- A new floater phone has been ordered and will allow client services staff to text client reminders about scheduled appointments. Staff find many clients do not answer phone calls from unknown numbers, and are confident they will improve communications by adding texting.

Purchasing

- Cat Condos all of the new cat condos purchased by the SCCAS Foundation have been installed and are in use or ready for use as kitten season approaches.
- Landscaping a new cordless leaf blower and chainsaw, and an electric power washer were purchased to assist the green team volunteers in maintain the extensive landscaping.

Fiscal

- Preparation of the FY 2023-24 budget is underway. The proposed budget will be presented at the April Board meeting.

Animal Control Report October 2022 through January 2023 Todd Stosuy, Field Services Manager

This report contains October and November reporting period information as well as that for December and January. I was on vacation at the time of the December meeting preparation and that report info was deferred to this meeting.

- 1. We have hired 4 new officers who have attended PC 832 Laws of Arrest and PC 832 Firearms during this period. Officer Cynthia Meidinger and Officer Athena DelRosario have passed the on-duty training period and have been released on their own. Officer Nicole Harding and Officer April Balke are still in training but should be released by March. All four officers are showing great enthusiasm, and each bring unique talents to the Agency.
- 2. With the addition of these officers, we informally re-started the Door-to-Door Outreach Program at the end of January in the City of Watsonville. In just one day of outreach, we assisted in proving free spay/neuters to 5 dogs, provided a free trolley system to one dog and restarted building the bridge between the community and our officers. This program is a community policing-based strategy of officers not acting in an enforcement capacity, doing foot patrols in underserved areas, and providing information and resources. If an officer does find an egregious case of cruelty or neglect, they will act on it.
- 3. In November we seized a dog from a Boulder Creek residence that had previously been declared a Vicious Animal for attacking humans. The dog violated its order and injured another human. We issued a destruction order, which was appealed and upheld by the Hearing Officer. The dog was humanely euthanized.
- 4. In November we assisted Watsonville Police and the Sheriff on a probation search and seized a dog. The owner had a court order prohibiting him from owning dogs due to a cruelty case we charged him with last year. His ex-wife attempted to reclaim the dog, but she also had a court order prohibiting her from owning dogs due to the same animal cruelty incident. The dog was unfortunately euthanized due to high prey aggression.
- 5. In December we seized two dogs from a houseless resident in the City of Santa Cruz and deemed one Vicious. This was an investigation into the dogs attacking and killing another houseless person's dog. The investigation found that only one of the owners' dogs was involved in the attack, so we released one dog to him. He appealed the Vicious Order on the second dog, and it went to hearing where it was upheld. The animal owner is now required to keep the dog leashed and muzzled at all times.
- 6. In October the Santa Cruz Police Department assisted us in seizing a dog from the Benchlands encampment after it attacked two separate people walking on the levee. An Assistant District Attorney was our main witness. The animal owner was verbally assaultive and threatening, but the dog was seized without incident. A hearing Officer upheld the seizure, and the dog was deemed Vicious. The animal owner did not appeal the Vicious Order or attempt to reclaim the dog and it was humanely euthanized.
- 7. In October we removed a dog and multiple fish from a residence in Boulder Creek after the owner was incarcerated on an unrelated matter. The animals were picked up at the Shelter a week later by a family friend.

- 8. In December we assisted Santa Cruz Police in seizing 4 living and 2 deceased cats from a residence where they had been abandoned. Charges were filed against the owner.
- 9. In November we responded to assist Santa Cruz Police after one of their Community Services Officers was bitten by a dog in Friendship Garden Park. The dog was seized since the owner did not have a residence to keep the dog under State ordered quarantine. The dog has been returned to its animal owner.
- 10. In January we assisted the Santa Cruz Police in an encampment eviction on Coral Street where they knew the above-mentioned animal owner and her dog (#9) were staying. We ensured officer and city worker safety from dogs during the cleanout.
- 11. In January we responded to the levee in Watsonville on a report of three dogs acting aggressively to people walking by. We responded and were charged by three dogs tethered together by a leash that appeared to have pulled a bush out of the ground that they had been tied to. All three dogs were impounded safely and have not been reclaimed.
- 12. In January we seized four cats from a houseless person in the City of Santa Cruz. She is a well-known cat hoarder who currently has a court date soon for an animal neglect case that occurred in April 2021 where 56 neglected cats were seized from her RV. In January of 2022 we seized an additional 13 cats from her RV. Since 2013 we have had contact with her numerous times and have seized cats from her on multiple occasions. The four cats we seized in January are up for adoption.
- 13. In January the above-mentioned cat hoarder (#12) contacted me to ask me to investigate another houseless person's RV for dog neglect. With the assistance of Santa Cruz Police, we seized four dogs for neglect. The dogs were re-homed.
- 14. In January we seized 36 chickens/roosters and 6 ducks from a neglectful situation in the City of Watsonville.
- 15. During the State of Emergency caused by the atmospheric river, we assisted in providing animal resources at all the human shelters on a daily basis throughout the event.
- 16. In January we impounded two horses in unincorporated Watsonville pursuant to an eviction. The animal owner has since reclaimed the horses and moved them to a new location.
- 17. In January we assisted Boulder Creek Fire and Equine Evac in rescuing two horses from a mudslide. The horses have returned home.
- 18. Our officers continue to handle routine calls for service on a daily basis, including but not limited too: aggressive animal calls, barking dogs, injured domestic and wildlife, dead animal removal, neglect complaints and bite investigations.
- 19. With the increase in staff, we have begun to conduct more proactive park patrols at parks with high number of complaints for dog off leash. These parks include: Aptos Polo Grounds, Seascape Park, Derby Park, Brommer Park, Jade Street Park, University Terrace Park and Highlands Park.
- 20. All new officers attended and passed State mandated euthanasia training.





The fiscal year (FY) 2022-23 December/January period reflects total revenues of \$235,572 and expenditures of \$840,296. Total YTD revenues were 65.81% of a potential 58.33%. Total expenditures were 54.42% of a potential 58.33%.

Year to date licensing revenues through January are \$137,342. Last year's YTD licensing revenues were \$148,756. Current YTD licensing revenues are 7.67% lower than last year. This shortfall is due to January web licensing revenues of \$13,352 not being recorded until February 1. Financial report licensing revenue for the next period will likely offset this shortfall as it will include January licensing revenue along with February and March.

SUBJECT: Registered Veterinary Technician Hiring and Retention Incentive Program

Recommendation

Adopt a resolution authorizing the Santa Cruz County Animal Services Authority (ASA) to establish a \$15,000 hiring and retention incentive program for general representation employees possessing a Registered Veterinary Technician license.

Discussion

The Shelter has experienced great difficulty in recruiting, hiring, and retaining Registered Veterinary Technicians (RVTs). The RVT position has been under continuous recruitment for almost a year and half (since Fall 2021) and the Shelter has received very few applications, with none moving on to the interview phase of the process.

Similar to the shortage of veterinarians, there is also a shortage of RVTs throughout the region and nation. The Shelter is competing against a variety of other facilities that offer higher pay and/or signing bonuses. The Shelter's benefits package, which includes medical insurance and a pension plan, is currently not as compelling when prospective employees can access competitive healthcare rates through Covered California and the high cost of housing poses a significant immediate affordability barrier to qualified applicants, despite the long-term benefit of vesting in a pension plan.

The RVT position requires possession of an RVT license, which involves completion of a two-year degree program and successful passage of the RVT examination. Additionally, several years of on the job training and experience are required to excel in the Shelter's challenging work environment where RVTs participate in high-volume spay/neuter clinics, triage sick animals, vaccinate Shelter animals, and perform a variety of animal health examinations and procedures on a daily basis.

In order to become a more attractive option for current job seekers and to improve retention, the Shelter proposes to offer a \$7,500 hiring incentive upon employment and an additional \$7,500 retention incentive upon completion of 2,080 hours of service (approximately one year). For equity, the Shelter would also provide existing general representation employees who possess an RVT license (two staff currently qualify) the \$7,500 hiring incentive now and the \$7,500 retention incentive after 2,080 hours of service (approximately one year) following receipt of the hiring incentive.

New hires or existing employees who receive the hiring incentive would be required to repay it if they leave within 2,080 hours of service (approximately one year) of receiving the initial incentive. Similarly, new hires or existing employees who receive the hiring and retention incentive would be required to repay the entire \$15,000 if they leave within 4,160 hours of service (approximately two years) of receiving the initial incentive. The Shelter's budget includes two RVT positions (one filled and one vacant) and one Animal Services Coordinator who possesses an RVT license.

Total cost is expected to be up to \$22,500 in FY 2022-23 and \$22,500 in FY 2023-24. The program would be used on an ongoing basis or until the ASA Board determines it is no longer necessary. Implementation of this program would begin upon approval of the ASA Board and the Santa Cruz County Board of Supervisors since general representation employment benefits are currently administered by the County of Santa Cruz.

RESOLUTION ESTABLISHING A HIRING AND RETENTION INCENTIVE PROGRAM FOR REGISTERED VETERINARY TECHNICIANS

WHEREAS, Registered Veterinary Technicians are essential to the Santa Cruz County Animal Services Authority's ("ASA") successful performance of many of its core activities including spay/neuter clinics, vaccinations and immunizations, health assessments, and euthanasia services; and

WHEREAS, the ASA has experienced great difficulty in recruiting, hiring, and retaining Registered Veterinary Technicians; and

WHEREAS, hiring and retention programs have proven effective in recruiting and retaining staffing in difficult to fill position.

NOW, THEREFORE, IT IS HEREBY RESOLVED AND ORDERED by the Board of Directors of the Santa Cruz County Animal Services Authority that the following actions be taken:

- 1) Establish a Registered Veterinarian Technician (RVT) hiring and retention incentive program;
- 2) Provide a hiring incentive of \$7,500 (minus legally required taxes) to any new hire or existing general representation employee who possess a valid RVT license;
- 3) Provide a retention incentive of \$7,500 (minus legally required taxes) to any new hire or existing general representation employee who possess a valid RVT license upon completion of 2,080 hours of service (approximately one year) following receipt of the hiring incentive;
- 4) Require payment to be based on full-time equivalent hours and be pro-rated for part-time employees;
- 5) Limit hiring and retention incentives payable to any one employee to \$15,000;

- 6) Require incentive recipients to reimburse the ASA the entire \$7,500 hiring incentive if they separate from ASA employment prior to completing 2,080 hours of service (approximately one year) after receipt of the hiring incentive;
- 7) Require incentive recipients to reimburse the ASA the entire \$15,000 hiring and retention incentive if they separate from ASA employment prior to completing 4,160 hours of service (approximately two years) after receipt of the hiring incentive;
- 8) Authorize the ASA to utilize the program on an ongoing basis or until a time when the ASA Board determines it is no longer necessary; and
- 9) Authorize the ASA Board Chair, ASA General Manager, Personnel Director, and the Auditor Controller Treasurer Tax Collector to take all necessary administrative actions to implement this resolution.

SUBJECT: Appointment of General Manager

Recommendation:

1. Appoint Amber Rowland to serve as General Manager effective March 23, 2023.

2. Approve the Employment Agreement between the Santa Cruz County Animal Services Authority and Amber Rowland, and authorize the Board Chair to execute the agreement.

Discussion:

Following a nationwide and competitive recruitment process, the Board of Directors selected Amber Rowland to serve as General Manager. Ms. Rowland comes to the Animal Shelter with 17 years of experience in animal services including shelter operations, animal behavior, control and handling, adoptions, volunteer coordination, community outreach, fundraising, event planning, and staff training. She's held multiple roles at Salt Lake County Animal Services and the City of Austin Animal Services Department, and she currently works for the City of Austin Public Health Department. She's passionate about animal welfare and has a clear understanding and appreciation of our approach as a socially conscious animal shelter.

During the special meeting on January 20, 2023, the Board met in closed session, unanimously selected Ms. Rowland as the General Manager, and appointed Ms. Coburn as its negotiator. Following the special meeting, Ms. Coburn extended a conditional job offer while Wendi Brown Creative Partners, Inc. completed thorough background and reference checks. Ms. Rowland will also be required to complete a preemployment in-processing session with the Santa Cruz County Personnel Department prior to her start date.

The Santa Cruz County Animal Services Authority (SCCASA) is the hiring authority for the General Manager who will serve pursuant to the attached Employment Agreement. This Agreement includes the following terms and conditions:

- Term Ms. Rowland's start date is March 23, 2023, and she is an at-will employee who serves at the pleasure of the Board.
- Salary Ms. Rowland will be hired at Step 6 with an annual salary of \$186,576, and she will receive a cost of living adjustment of 3% on September 16, 2023 and September 14, 2024.

- Hiring and Retention Incentive Ms. Rowland will receive a hiring and retention incentive of \$30,000, which will be reimbursed if she leaves before three years.
- Vacation Leave Approximately 31 days per year based on her years of service with other public agencies.
- Sick Leave Advanced 48 hours offset against the regular rate of accrual on a per pay period basis as the credit is exhausted.
- Administrative Leave Advanced 40 hours to be used as paid time off and accrue 80 hours annually to be taken as leave or in cash.
- Moving Expenses Up to \$10,000 for relocation expenses upon submittal of receipts.

The Board wishes to thank Mr. Gaffney for stepping in as Interim General Manager and balancing this role with his roles as County Parks Director. He's done an incredible job leading the Animal Shelter since October 2022. The Board also wishes to thank Ms. Townsend, the SCCASA Attorney, for partnering with Mr. Gaffney to help with on-site management and operational support services during the recruitment and transition.

EMPLOYMENT AGREEMENT

This Employment Agreement ("AGREEMENT") by and among the Santa Cruz County Animal Services Authority, a public entity formed pursuant to Section 6500 *et. seq.* of the California Government Code (hereinafter referred to as "SCCASA"), and Amber Rowland, an individual (hereinafter referred to as "EMPLOYEE") (collectively referred to hereafter as the "Parties"), is entered into on the date by which it has been duly approved and executed by all Parties hereto.

WHEREAS, the SCCASA was established pursuant to a Joint Powers Agreement executed on June 18, 2002; and

WHEREAS, the Joint Powers Agreement provides that the Board of Directors of the SCCASA shall appoint the General Manager for the SCCASA; and

WHEREAS, the SCCASA desires to hire EMPLOYEE as the General Manager and EMPLOYEE desires to serve as the General Manager for the SCCASA beginning March 23, 2023; and

WHEREAS, the SCCASA and EMPLOYEE agree and acknowledge that EMPLOYEE's employment as General Manager is governed by this Agreement.

NOW, THEREFORE, in exchange for the mutual promises, covenants and conditions contained herein, the Parties mutually agree as follows:

1. Duties

- (a) EMPLOYEE is hereby employed as the General Manager of the SCCASA. EMPLOYEE shall do and perform all services, acts, or things necessary to conduct the operations of the SCCASA in the EMPLOYEE's capacity as the General Manager.
- (b) EMPLOYEE shall perform their duties to the best of their ability in accordance with the highest professional and ethical standards of the profession and shall comply with all general rules and regulations established by the SCCASA and relevant laws and regulations governing animal services in California.
- (c) EMPLOYEE shall not engage in any activity, which is or may become a conflict of interest, prohibited by contract, or which may create an incompatibility of office as defined under California or Federal laws. EMPLOYEE shall comply fully with their reporting and disclosure obligations under regulations promulgated by the Fair Political Practices Commission (FPPC) and the SCCASA.
- (d) EMPLOYEE shall dedicate their full energies and qualifications to their employment as General Manager, and shall not engage in any other duties or services for compensation except as may be specifically approved in writing in advance by the Board of Directors of the SCCASA.

2. Term

EMPLOYEE acknowledges that they are an at-will employee who serves at the pleasure of the SCCASA. As such, their employment may be terminated by the SCCASA without cause. The term of this Agreement shall begin on March 23, 2023. This Agreement will be of indeterminate length subject to the termination clause in Section 5 or until terminated by the event of retirement, death or permanent disability of EMPLOYEE.

3. Salary

- (a) EMPLOYEE's initial annual salary will be \$186,576 payable in installments at the same time as other employees of the SCCASA are paid and subject to customary payroll taxes and withholding. EMPLOYEE's salary is compensation for all hours worked and for all services rendered under this Agreement. EMPLOYEE shall be exempt from overtime pay provisions of California law (if any) and Federal law.
- (b) EMPLOYEE shall receive a hiring and retention incentive of \$30,000 payable in two installments and subject to customary payroll taxes and withholding. The first installment of \$15,000 will be paid with the first pay period of employment. The second installment of \$15,000 will be paid upon completion of 2,080 hours of service. EMPLOYEE shall reimburse the SCCASA for the entire hiring and retention incentive if the EMPLOYEE leaves SCCASA employment prior to completing 6,240 hours of service.
- (c) EMPLOYEE shall receive a cost of living adjustment (COLA) of 3% on September 16, 2023 and September 14, 2024.
- (d) SCCASA shall evaluate the performance of EMPLOYEE at their six (6) month anniversary, one year anniversary, and at least once per year thereafter. EMPLOYEE shall have a performance evaluation in writing. In connection with annual evaluations, EMPLOYEE may qualify for a merit salary increase equal to 5% of EMPLOYEE's salary. The granting of a merit salary increase shall be entirely at the discretion of the SCCASA. Either as part of the evaluation or otherwise, the SCCASA may establish performance goals and objectives, as appropriate. Evaluations may be conducted more often at the SCCASA's discretion. EMPLOYEE will request and schedule the minimum required evaluations as appropriate under the SCCASA's agenda procedures or as otherwise directed by the SCCASA.

4. Benefits

The following benefits will be provided to EMPLOYEE:

- (a) <u>Vacation Leave.</u> EMPLOYEE shall accrue paid vacation at the rate of .1192 hours per hour of paid service (approximately 31 days per year). EMPLOYEE is eligible for vacation after 2,080 hours of service.
 - (b) Sick Leave. EMPLOYEE shall be advanced 48 hours of sick leave offset

against the regular rate of accrual on a per pay period basis as the credit is exhausted. EMPLOYEE shall accrue sick leave at the rate of .0231 per hour of paid service which is equivalent to 48 hours per year.

- (c) <u>Administrative Leave</u>. EMPLOYEE shall be advanced 40 hours of administrative leave to be used as paid time off. EMPLOYEE shall accrue 80 hours of administrative leave per year on-going which may be taken as leave or in cash. Any administrative leave earned during a year and not taken will be cashed out the last pay date of the calendar year.
- (d) <u>Moving Expenses.</u> EMPLOYEE shall receive up to \$10,000 for expenses, pursuant to Internal Revenue Service guidelines, for relocation to Santa Cruz County upon submittal of receipts acceptable to the SCCASA.
- (e) <u>Business Expense Allowance.</u> EMPLOYEE shall receive \$100 per year paid at end of 1st quarter of the fiscal year.
- (f) <u>Mileage Reimbursement</u>. EMPLOYEE shall receive mileage reimbursement for out-of-county travel on SCCASA business in authorized private vehicle in accordance with the Santa Cruz County Auditor-Controller/Treasurer-Tax Collector's guidelines.
- (g) <u>Holidays.</u> EMPLOYEE shall receive 14 days a year which follow the Santa Cruz County Government Center holiday calendar.
- (h) <u>Jury Duty/Required Court Leave</u>. EMPLOYEE shall be granted leave with pay from their work for such time as they may be required to serve in a court of law.
- (i) <u>Bereavement Leave.</u> EMPLOYEE shall receive three (3) days in California and five (5) days out-of-state.
- (j) OASDI (FICA). EMPLOYEE and SCCASA shall each pay a contribution of 7.65%.
- (k) Retirement. EMPLOYEE shall participate in the California Public Employee's Retirement System (PERS) 2% at 62 Plan, with a maximum benefit factor of 2.5% at 67, three-year final average formula. EMPLOYEE shall be required to pay the 7% employee share of the PERS retirement contributions. SCCASA currently obtains retirement benefits through the County of Santa Cruz. SCCASA is in the processing of establishing a contract with CalPERS in collaboration with the County of Santa Cruz.
- (l) <u>Health, Dental, Vision, Life Insurance and Long Term Disability.</u> EMPLOYEE is eligible for health, dental and vision care benefits, group term life insurance, and long term disability insurance as provided to SCCASA employees by the plans administered by the Santa Cruz County Personnel Department, Benefits Division.

5. Resignation and Termination

- (a) <u>Voluntary Termination</u>. Either EMPLOYEE or SCCASA may terminate this Agreement by providing the other party at least 30 days' advance written notice of such intention to do so and prior to the effective date of termination. In the event that SCCASA voluntarily terminates this Agreement and there is no basis for termination of EMPLOYEE for cause, EMPLOYEE may receive severance pay as set forth in Section 6.
- (b) <u>Termination for Cause.</u> Termination "for cause" shall mean: if EMPLOYEE willfully breaches the duties which EMPLOYEE is required to perform under the terms of this Agreement or engages in gross misconduct detrimental to the operation of the business of SCCASA, as determined in the sole discretion of the SCCASA, or engages in a willful violation of federal or state law, or is convicted of a felony. The SCCASA may terminate this Agreement for cause by giving written notice of termination to EMPLOYEE, and such termination will be effective immediately upon notice of the termination. If EMPLOYEE is terminated for cause, EMPLOYEE shall <u>not</u> be entitled to severance pay pursuant to Section 6, below.
- (c) <u>Effect of Termination on Compensation.</u> In the event of termination of this Agreement, EMPLOYEE shall be entitled to the compensation described in Section 3 earned up to the date of termination, computed pro rata, as well as all vacation leave accrued.

6. Severance Pay

If EMPLOYEE is terminated by the SCCASA pursuant to Paragraph 5(a), EMPLOYEE shall receive a severance payment equal to six (6) month's salary upon EMPLOYEE's fully executed waiver of all claims against SCCASA in a form satisfactory to SCCASA. Additionally, EMPLOYEE shall receive payment for all vacation leave accrued to the date of separation. Such payment will release SCCASA from any further obligations arising out of the employment.

If the conditions of Paragraph 5(b) are met or if EMPLOYEE is terminated because of conviction of any criminal offense involving dishonesty, fraud, misrepresentation, or other acts of moral turpitude, then EMPLOYEE shall <u>not</u> be entitled to any severance pay (except accrued vacation leave) set forth in this paragraph.

7. Amendment

This Agreement may be amended, modified, or changed by the Parties provided that said amendment, modification or change is in writing and approved by all the Parties to this Agreement.

8. Notices

All notices required herein shall be sent first class mail to the Parties as follows:

Notices shall be deemed effectively served upon deposit in the United States mail.

9. Representation by EMPLOYEE

EMPLOYEE represents that the EMPLOYEE has read this Agreement, fully understands the terms and conditions of the Agreement and is knowingly and voluntarily executing this Agreement, and acknowledges that EMPLOYEE had the opportunity to seek the advice of legal counsel before signing it.

10. Entire Agreement

This Agreement contains the entire agreement among the Parties hereto. No promise, representation, warranty, or covenant not included in this Agreement has been or is relied on by any party hereto. This Agreement, the Joint Powers Agreement, and amendments thereto are the sole and exclusive basis for an employment relationship among EMPLOYEE and SCCASA, and its terms supersede any and all rules, regulations, guidelines, or other express or implied terms that would otherwise be applicable to employment by the SCCASA, including but not limited to any SCCASA personnel rules.

11. Construction of Agreement

EMPLOYEE acknowledges that she has reviewed this Agreement and that the normal rule of construction to the effect that any ambiguities are to be resolved against the drafting party shall not be employed in the interpretation of this Agreement.

12. California Law

This Agreement and the rights and obligations of the Parties shall be construed, interpreted, and enforced pursuant to the laws of the State of California, except that this Agreement shall be given a fair and reasonable construction in accordance with the intention of the Parties and without regard to, or aid of, Section 1654 of the California Civil Code.

13. Severability

If any provision of this Agreement is deemed invalid or unenforceable by a court of law, it shall be considered deleted herefrom and the remainder of the provision and of

this Agreement shall be unaffected and shall continue in full force and effect.

14. Waiver

The failure of the SCCASA or EMPLOYEE to insist on strict compliance with any of the terms, covenants or conditions of this Agreement by the other party shall not be deemed a waiver of that term, covenant or condition, nor a waiver or relinquishment of any right or power.

15. Headings and Captions

The headings and captions appearing in this Agreement are inserted only as a matter of convenience and in no way limit or affect the substantive terms of the Agreement.

16. Counterparts

The Parties may execute this Agreement in counterparts, which shall, in the aggregate, be deemed an original but all of which, together, shall constitute one and the same instrument. A scanned, electronic, facsimile or other copy of a party's signature shall be accepted and valid as an original.

JPA Board Meeting January 20,2023

Good morning.

I'm Joan DeNeffe. I had the privilege of being on the hiring panels for the General Manager. I have been involved with animal sheltering and rescue for over 30 years. First as a veterinary technician then as a board member for the Oregon Humane Society. I moved to Santa Cruz in 1983 when my husband at the time Doug Fakkema became the GM. I have served the organization in a variety of roles as its first volunteer, as a board member and president of the SPCA and most recently under Melanie as chairperson of the marketing committee, dog trainer and volunteer in several other capacities.

I'd like to speak to a few things I feel are important when thinking about hiring a new General Manager for Santa Cruz County Animal Shelter.

The Shelter like all organizations have been through hell and back with Covid, the CZU fires and now the January storms. I feel we are at a crossroad. There are several things at play, the cost of housing for the employees, a staff that has been over worked and is feeling a lack of support and donors that have expressed concern about supporting an organization without a clear direction.

The Shelter does have important things to build on, like the progressive policies that reduced the number of animals coming into the shelter. The critically important spay/neuter program and the community outreach program for animal control that educates and helps to keep animals in their homes. We have shelter employees that understand animal behavior that enables us to make better matches, so animals are going into homes that work for the animal and the lifestyle of the adopters, helping to insure forever homes. Our foster program is so important to help reduce the stress of dogs in the shelter. And our two Catio Tours promoting indoor cats by educating the community about Catios.

In the last 12 years because of these and other programs the reputation of SCCAS has been elevated in our community so that we have been able to attract crucial volunteers and increased fundraising and decreased the euthanasia rate by partnering with close to 30 placement partners, that take animals we don't have the resources to place, this helps the budget in so many ways.

But there is always more to do. There are plans to build out the second phase of the shelter upgrade. The Foundation has already received a donation of over 1 million dollars for this purpose.

I do want to take the time to thank the JPA board for increasing the salary level of the new GM so that we could attract dynamic candidates.

For a new General Manager to be successful I feel it is imperative to get the spay/neuter program up and running. These are tough times for the Veterinary community. Good Veterinarians that can do high volume spay/neuter are in short supply. We have a law mandating spay/neuter. Ensuring our community has access to low cost spay/neuter will save lives, reduce the population of homeless animals over time which translates into reduced costs to the budget. Recently a study was done showing that 21 million dogs and cats that usually would have been neutered in the years of Covid did not. That means that we are looking at a nationwide growth of the over population of dogs and cats. The average cost to spay or neuter a dog in Santa Cruz County is \$600. To \$1000. This is already showing up in our Shelter. Santa Clara Animal Services just offered a large signing bonus to attract and hire a qualified Veterinarian. Having a low cost spay neuter program is critical to supporting our pet owning community and getting them to support us.

Also, we are lucky that we do have some very dedicated staff but unlike the GM position, staff wages have not been upgraded to help them deal with the cost of living. I know that budgets are tight but for this organization to retain those employees, attract new employees and to continue to provide the programs our community has come to expect and to deserve the donations we will need to support our vision this needs to change.

The new General Manager's challenge will be to maintain and enhance the programs our community has come to expect in order to continue to have community support and attract the donors and volunteers critical to moving this organization forward.
